The Board of Education recognizes the need for students, teachers, administrators, and other school personnel to have a safe and supportive educational environment that is conducive to teaching and learning. The Board believes schools should undertake proactive, preventive approaches to ensure a positive school climate and culture that fosters learning and personal-social development. Public schools should undertake proactive, preventive approaches which integrate services using a Multi-tiered System of Supports (MTSS) framework which promote students' academic success, behavioral and mental health, including social and

Level 3 behaviors are criminal offenses and therefore warrant formal law enforcement intervention that may result in issuance of a criminal citation, ticket, or summons, filing a delinquency petition, referral to a probation officer, or actual arrest.

In collaboration with law enforcement, the school shall also implement intervention strategies and meaningful consequences that promote and support appropriate behavioral changes. These strategies include but are not limited to:

- 1. Administrator/Student conference or reprimand.
- 2. Administrator and teacher-parent/guardian conference.
- 3. Referral to support staff or agencies for counseling or other therapeutic services.
- 4. Notification of appropriate Health and Human Resources.
- 5. Daily/Weekly progress reports.
- 6. Behavioral contracts.
- 7. Change in the student's class schedule.
- 8. School service assignment.
- 9. Confiscation of inappropriate item(s).

If a teacher removes a student for an inappropriate behavior that behavior the student must be removed from the teacher's class the remainder of the day. If the student is removed from a classroom a total of three times, by the same teacher, in one calendar month for one or more of the behaviors, the student shall receive as determined by the principal an in-school suspension, an out-of-school suspension, or may be considered for placement at Crossroads Academy the designated Cabell County alternative learning location. However, if a student is referred to Crossroads Academy alternative learning location, we the school and district leadership team would follow the guidelines in the Cabell County Alternative Learning Guide. The teacher must record the behavior in WVEIS within 24 hours. Principals must support teachers in the discipline of students if proper cause and documentation is provided. A teacher may not be reprimanded if their actions are legal and follow Cabell County Policy 5600.

A Comprehensive Multi-Tier System of Support (MTSS) framework for student behavior and punishment is designed to promote positiv

Examples of Interventions:

- A. Functional Behavior Assessment (FBA) to identify underlying triggers and functions of behavior.
- B. Development of highly individualized Behavior Intervention Plans (BIPs) targeting specific behaviors with evidence-based strategies.
- C. Collaborative support from mental health professionals, external agencies, or community resources.

Examples of Consequences:

- A. Temporary removal from the classroom or school setting, with appropriate supervision and alternative educational services provided.
- B. Restorative justice practices, such as conflict resolution processes involving all affected parties.
- C. Involvement of parents/guardians and development of a safety plan, as needed, to ensure the well-being of all students and staff.

This policy shall appear in the student and staff handbooks and if no handbook is available, a copy will be distributed to all students, faculty, and staff.

The District and/or school shall develop and implement training for students and staff on these regulations and on means for effectively promoting the goals of this policy.

Plans for the implementation of West Virginia Board of Education Policy 4373 and this policy should be included within individual school strategic plans. The implementation plan shall reflect the particular needs of students and staff to study, learn, and work in a positive school climate/culture. To the maximum extent possible, the plan should be developed collaboratively with input from all stakeholders including, but not limited to parents, business leaders, community organizations and State and local agencies. The plan should articulate and incorporate the partnership supports and resources that are available to the school through the District's formal and informal partnership agreements as well as through additional school-level partnerships.
